

## **Defiance County Board of DD Meeting Minutes**

## March 25, 2025

## 5:15 pm

• The March regular board meeting of the Defiance County Board of Developmental Disabilities was held March 25, 2025 at the Defiance County Board of DD.

• The meeting was called to order by Ms. Kim Hurtig at 5:15 p.m. Board members present were Mr. Clayton Crates, Ms. Roberta Phlipot, and Ms. Ruby Schindler. Board member, Ms. Stephanie Meyer, attended remotely via Zoom. Board members excused were Ms. Jami Cameron and Ms. Beth Headley. Approximately 8 others, consisting of Board employees and members of the public were also present.

• Motion was made by Ms. Phlipot and seconded by Ms. Schindler to approve the February 25, 2025 Board Meeting minutes.

• Motion was made by Ms. Phlipot and seconded by Ms. Hurtig to approve the Resolution pertaining to the Provision of Educational Services for 2025-2026 School Year . *Motion approved unanimously via roll call.* 

• Revision of the Developmental Specialist job description was tabled until the April board meeting to allow the Union time to review the position and give feedback, if any.

• Mr. Clayton Crates asked about the current financial cuts at the Federal level and potential impact on the Defiance County Board of DD budget and service delivery.
